Public Comment

Judge Kleinpeter called for public comment. There were no public comments.

Regular Business

Mr. Bickham moved, seconded by Ms. Lansing, to approve the minutes of March 26, 2015 and May 22, 2015, meeting of the Legislative Committee. With no objection or discussion, the motion carried.

New Business

Ms. LeBlanc gave a summary of legislation that passed during the 2015 Regular Session of the Legislature:

HB 42 (Jones)

Would authorize a cost-of-living adjustment (COLA) of up to 1.5% for eligible LASERS retirees and their beneficiaries, effective July 1, 2015. It was supported by the Board. It was vetoed by the Governor.

HB 33 (Berthelot)

Would increase littering fines and distribute 50 percent of the fines to the retirement system of the law enforcement agency issuing the litter citation. The funds would be used to decrease debt. The LASERS Board supported the bill, insofar as it reduces debt. It awaits action by the Governor.

HB 46 (Reynolds)

Provides for survivor benefits for minor children of wildlife enforcement agents, allowing benefits for unmarried full-time students to the age of 23. The LASERS Board was neutral on this bill. It has been signed by the Governor and is now Act 44, effective June 5, 2015.

HB 800 (Fannin)

Appropriates surplus funds to LASERS to be applied to the initial unfunded liability of the system, as required by the Constitution. It has been signed by the Governor and is now Act 56.

Other Business

Mr. Jobert commented that RSEA agreed to an effective date of July 1, 2016, as the Senate amendments and initial conference committee report on HB 42 proposed, and the association stood by their commitment.
