Re: 2019 – 2020 Employer Contribution Rates

At its February 25, 2019 meeting, the Public Retirement Systems' Actuarial Committee (PRSAC) approved the employer contribution rates for Fiscal Year 2019 – 2020.

These rates are detailed in the attached table, *LASERS 2019-2020 Contribution Rates by Plan*, which should be used to calculate employer contributions to LASERS beginning July 1, 2019.

These rates are effective for all payrolls with a payment date of July 1, 2019 or later, irrespective of the pay-period date.
