## Market Impact in 1st Quarter 2019


The Fed announced expectation to not raise interest rates for 2019 and only once in 2020 due to slower economic growth. Target range is 2.25% - 2.5%.

1Q posted strong returns:

- In Equities
  - S&P 500 returned 13.6%
  - MSCI World Ex-USA returned 8.7%
  - MSCI Emerging Markets returned 10.0%
- In Fixed Income
  - Barclay's Aggregate returned 2.9%
  - J.P. Morgan GBI-EM Global Diversified returned 2.9%
