Re: 2020-2021 Employer Contribution Rates

Date: February 26, 2020

At its December 18, 2019 meeting, the Public Retirement Systems' Actuarial Committee (PRSAC) approved the employer contribution rates for Fiscal Year 2020-2021.

These rates are detailed in the attached table, *LASERS 2020-2021 Contribution Rates by Plan*, which should be used to calculate employer contributions to LASERS beginning July 1, 2020.

These rates are effective for all payrolls with a payment date of July 1, 2020 or later, irrespective of the pay-period date.
