Re: 2021 – 2022 Employer Contribution Rates

Date: January 7, 2021

At its December 14, 2020 meeting, the Public Retirement Systems' Actuarial Committee (PRSAC) approved the employer contribution rates for Fiscal Year 2021-2022.

These rates are detailed in the attached table, *LASERS 2021-2022 Contribution Rates by Plan*, which should be used to calculate employer contributions to LASERS beginning July 1, 2021.

These rates are effective for all payrolls with a payment date of July 1, 2021 or later, irrespective of the pay-period date.
