Re: 2022 – 2023 Employer Contribution Rates

Date: January 11, 2022

At its December 16, 2021 meeting, the Public Retirement Systems' Actuarial Committee (PRSAC) approved the employer contribution rates for Fiscal Year 2022-2023.

These rates are detailed in the attached table, *LASERS 2022-2023 Contribution Rates by Plan*, which should be used to calculate employer contributions to LASERS beginning July 1, 2022.

These rates are effective for all payrolls with a payment date of July 1, 2022 or later, irrespective of the pay-period date.
