Re: 2024-2025 Employer Contribution Rates

Date: February 7, 2024

At its December 14, 2023 meeting, the Public Retirement Systems' Actuarial Committee (PRSAC) approved the employer contribution rates for Fiscal Year 2024-2025.

These rates are detailed in the table below, *LASERS* 2024-2025 Contribution Rates by Plan, which should be used to calculate employer contributions to LASERS beginning July 1, 2024.

These rates are effective for all payrolls with a payment date of July 1, 2024, or later, <u>irrespective</u> of the pay-period date.
