# **NEW BUSINESS**

# Goldman Sachs International Small Cap Equity Portfolio Review

Mr. Osman Ali, Mr. Nick Barker, and Mr. Taylor Walsh, all with Goldman Sachs, conducted a review of the International Small Cap Equity Portfolio.

#### Discussion & Recommendation of International Small Cap Allocation

Based on performance in the Mondrian International Small Cap Portfolio, the Investment staff and NEPC recommended that LASERS terminate the contract with Mondrian and move the assets to the Goldman Sachs International Small Cap Equity Portfolio.

Ms. Mathews moved, seconded by Judge Kleinpeter, to terminate the Mondrian International Small Cap Equity contract and reallocate the proceeds to the Goldman Sachs International Small Cap Portfolio. With no further discussion, and no objections, the motion carried.

#### **Monthly Performance Report**

Mr. Beale reviewed the Total Plan performance. He stated that the final monthly return for October 31, 2023, was -1.8%, making the Total Plan FYTD return -2.7%.

#### **Annual Reports**

Mr. Beale presented Annual Reports including the Internal Funds Report, Total Plan Trading Reports, Proxy Voting Reports, Class Action Litigation Report, Withholding Tax Reclaim Report and the Custodian Report as required by the Statement of Investment objectives.

### **Orleans Capital Discussion**

Mr. Beale and Mr. Barnes discussed that Orleans Capital Management will be acquired by Argent Financial Group. Orleans will be left as a stand-alone entity and will retain its name and existing office locations, with no expected changes to its personnel or portfolio management strategies and processes.

Judge Kleinpeter moved, seconded by Ms. Mathews, to assign the Orleans Capital Management contract to Argent Financial Group, Inc. pursuant to no changes in services and fees. With no further discussion, and no objections, the motion carried.

# **OTHER BUSINESS**

Mr. Barnes stated that Apogem Capital will be in next month.

No other business was brought before the committee and the meeting adjourned at 1:39 p.m.
