2024 Louisiana Legislative Session OUTCOME OF RETIREMENT LEGISLATION

The 2024 Regular Session of the Louisiana Legislature came to an end on June 3, 2024. This year, lawmakers proposed ten bills that, if passed, would have impacted LASERS. By the end of the session, six of those bills passed.

SB 1 by Sen. Price passed and is now **Act 46**. This legislation specified, that for transfers between systems, "employer contributions" are defined as only those employer contributions that are actuarially required. The LASERS Board was neutral on this bill.

HB 782 by Rep. McFarland passed and is now **Act 776**. This legislation allocates an additional \$9.9 million to LASERS to apply to the balance of the initial unfunded accrued liability (IUAL). The LASERS Board supported this bill.

SB 462 by Sen. Hodges passed and is now **Act 491**. The bill originally permitted the Governor to elect and appoint the chairman or any other officer of each state board and commission. However, the bill was amended and now only applies to those boards where a majority of the members are appointed by the Governor, thus not impacting LASERS.

Two resolutions and one study resolution passed and do not require the Governor's signature.

HCR 20 by Rep. Johnson memorializes Congress to review and eliminate the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) by supporting H.R. 82 and S. 597 of the 118th Congress. See page 5 for details. Another resolution, **HR 267** by Rep. Melerine, requests state retirement systems to submit reports regarding procedures for proxy voting.

HSR 4 by Rep. Riser requests the House Committee on Retirement to study the benefits available to beneficiaries of a member of a state retirement system killed in the line of duty by an intentional act of violence and to report its findings prior to the 2025 Regular Session.

Retirement bills that failed to pass through the legislative process were relative to retirement eligibility, ESG investing, and proxy voting. For a complete list of retirement legislation outcomes, visit *www.lasersonline.org/2024-legislative-session*.

Our team worked tirelessly throughout the session to engage with legislators and other retirement systems, discussing, drafting, and amending various measures impacting our System. We are pleased with the outcome of this session and remain committed to safeguarding the benefits for our current and future retirees.

I am also pleased to share that LASERS ended the fiscal year on June 30 with a preliminary market return of 13.5%. This achievement is a testament to the excellent guidance provided by our Board of Trustees and the skillful management of our investments team, who oversee over one-third of our portfolio internally. Finalized returns will be available on our website soon.

Additional key accomplishments over the past fiscal year include improved data security, a new seminar, a new website, and national recognition for excellence in financial reporting and government communications.

Data Security

Protecting your personal and financial information is our top priority. LASERS has significantly bolstered its data security efforts, dedicating substantial time and resources to safeguarding your information. While no system is entirely immune to security challenges, we continuously monitor and update our security protocols. We are confident in our team's expertise and dedication to maintaining the highest data protection standards for our members.

Seminars

Our education team introduced a new seminar, "Calculating Your Benefit," earlier this year. This 1.5-hour session thoroughly explains how LASERS retirement benefits are calculated, explores retirement options, demonstrates the benefit estimate calculator in myLASERS, and clarifies how to interpret your benefit estimate. LASERS RECOGNIZED FOR EXCELLENCE

Various LASERS reports have recently been acknowledged as exemplary representations of excellence in financial reporting and government communications.

For the 27th consecutive year, the Government Finance Officers Association (GFOA) has awarded LASERS the Certificate of Achievement for Excellence in Financial Reporting for its *Annual Comprehensive Financial Report* (ACFR) for the fiscal year ending June 30, 2023. 








THE LASERS WEBSITE HAS A NEW LOOK!

HOW TO RESET YOUR PASSWORD

Forgot your myLASERS password? No worries! Follow these simple steps to reset it quickly without having to contact LASERS:

- 1. Visit the Sign In Page: Go to mylasers.org. Click on Need help signing in? then Forgot password? to access the password reset options.
- **2. Enter Your Email Address:** Choose your preferred method for resetting your password:
 - **SMS Text:** Receive a six-digit verification code via text message.
 - **Voice Call:** Get a six-digit verification code through a phone call.
 - Email: Receive an email with a reset link.
- 3. Verification:
 - If you choose SMS Text or Voice Call, enter the received code and click Verify. Didn't receive a code? Select Didn't receive a code? Reset via email under the Verify button.
 - If you choose Email, click the green Reset Password button in the email you receive, which will have "Account password reset" in the subject line.
- **4. Reset Your Password:** On the reset screen, enter and confirm your new password, then click *Reset Password*.

You're all set! If you followed these steps, you have successfully created a new myLASERS password.

Note: If you have made too many failed attempts and caused your account to be locked, you will not be able to reset your password. Please contact LASERS customer service for assistance.

A frequently asked question at LASERS is, "What's the latest on the WEP and GPO?" This topic gains particular attention during the Louisiana Legislative Sessions, as LASERS often sends out retirement legislation updates that

include a resolution urging lawmakers to support the elimination of these Social Security offsets. This year, House Concurrent Resolution 20 (HCR 20) by Rep. Johnson received final passage in May. Similar resolutions pass almost every session.

The LASERS Board strongly supports the reduction or elimination of the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). However, it's important to remember that any changes to these federal offsets must be made at the **federal** level.

Legislation to repeal programs that reduce or eliminate Social Security retirement benefits remains a significant topic in Congress. The Social Security Fairness Act of 2023 (HR 82), sponsored by Representative Garrett Graves (R-LA) and co-sponsored by over 300 members of the U.S. House of Representatives, aims to eliminate both the WEP and GPO. As of now, there have been no changes regarding the WEP and GPO. While lawmakers have not acted on any 2023 legislation related to these provisions, the House Ways and Means Subcommittee on Social Security held an informational hearing on the topic in April. Although no action resulted from the hearing, committee members discussed potential solutions and noted that the Social Security Administration now has better worker data than when the WEP and GPO were initially implemented.

LASERS will continue to monitor federal and state legislation regarding changes to the WEP and GPO and will keep members informed of any updates. The Retired State Employees Association (RSEA) also monitors this legislation and is committed to the elimination of these offsets.

As always, we also encourage you to contact your congressmen directly regarding the WEP and GPO.

Please note that the September 1 benefit payment falls on a Sunday, which could affect receipt of your funds. Direct deposits are guaranteed to be in your bank or credit union on the first day of the month. Be aware that if the first falls on a weekend or holiday, funds may not be available until the following business



day. In these cases, contact your financial institution directly to know when your funds will be made available to you. **That decision is made by your financial institution, not LASERS.**

Update Your Address

It is important that the Office of Group Benefits (OGB) has a current mailing address for all OGB members. Throughout the year, OGB sends information to members by postal mail. OGB wants to ensure these mailings are reaching members.

Additionally, if you are a retiree with Medicare AND you receive your mail at a Post Office Box, Medicare requires that you also have a street address on file.

ASK LASERS Your Questions Answered

Q: I HAVE THE MINIMUM NUMBER OF YEARS FOR MY PLAN, BUT NOT THE AGE. I WILL BE SEPARATING FROM STATE SERVICE. IF I DO NOT REFUND, WHEN SHOULD I APPLY TO RETIRE?

You will reach retirement eligibility when you reach the age required for your plan, and you can retire out of state service. You should contact LASERS up to a year in advance of your retirement age. You can apply up to six months ahead of your birthday. The effective date of your retirement will be the later of your birthday or the date the application is received. If the application is received after your eligibility date, you will not receive retroactive benefits.

Q: I CANNOT ATTEND THE PREP SEMINARS ON THE AVAILABLE DATES. ARE THEY RECORDED?

Yes! Recordings of the PREP seminar and DROP vs. IBO seminar, in addition to other important topics, are available in the video library on our website. We encourage you to browse the video library to learn about different LASERS topics and to refresh your memory if you have previously attended.
