Regular Business

Ms. Hodges called for approval of the minutes of the March 25, 2024, Legislative Committee meeting. Ms. Mathews moved, seconded by Ms. McManus, to approve the minutes. With no objection or discussion, the motion carried.

New Business

Ms. Grant provided a status update on the bills being tracked this session.

SB 1 – Price Position: Neutral

Systems Impacted: State & Statewide

Provides relative to transfers of service credit between systems by specifying that, for purposes of transfers between systems, "employer contributions" are defined as only those employer contributions that are actuarially required.

SB 5 - Miguez

Systems Impacted: State & Statewide

Requires fiduciaries for public retirement systems to make investment decisions based solely on financial factors.

Senate Retirement – Amended by Substitute, Remains in Committee

SB 462 – Hodges

Permits the governor to elect to appoint the chairman, or any other officer, of each board and commission whose appointment is not otherwise provided for in the Constitution of Louisiana.

HB 30 – Bagley Position: Neutral

System Impacted: LASERS

Adds a new category of retirement eligibility. Permits any rank-and-file member, regardless of age or first date of employment, to retire with 25 years of service credit.

- House Retirement Reset for hearing on 5/1

HB 782 - McFarland

Systems Impacted: LASERS

Makes supplemental appropriations for Fiscal Year 2023-2024 – allocates an additional \$8.9 million [amended to \$9.9 million] to LASERS to apply to the balance of the IUAL.

- House Floor Amended and Passed [Y:102/N:0]

HB 800 - Beaullieu

Calls a constitutional convention to convene on May 20, 2024, to be composed of 171 delegates, who are the 105 members of the House of Representatives, the 39 members of the Senate, and 27 delegates appointed by the governor. Requires the convention to complete a new constitution by July 15, 2024.

HB 902 - Melerine

Systems Impacted: State & Statewide

Provides relative to the voting of shares held by retirement systems based on advice of proxy advisory firms.

Position: Oppose

HCR 20 - Johnson

Memorializes congress to review and eliminate the WEP and GPO by supporting H.R. 82 and S. 597 of the 118th Congress.

- House Floor Passed [Y:97/N:0]
- Senate Retirement Scheduled for 4/29

Ms. Mathews moved, seconded by Mr. Decoteau, to take a neutral position on SB 5 by Senator Miguez. With no objection or discussion, the motion passed.

Ms. McManus moved, seconded by Ms. Hutchinson, to take a neutral position on HB 30 by Representative Bagley. With no objection or discussion, the motion passed.

Ms. Hutchinson moved, seconded by Ms. Mathews, to support HB 782 by Representative McFarland. With no objection or discussion, the motion passed.

Ms. McManus moved, seconded by Ms. Hutchinson, to oppose HB 902 by Melerine. With no objection or discussion, the motion passed.

Mr. Broussard moved, seconded by Ms. McManus, to support HCR 20 by Representative Johnson. With no objection or discussion, the motion passed.

Ms. McManus moved, seconded by Mr. Broussard, to oppose SB 462 by Senator Hodges. With no objection or discussion, the motion passed.
