Private Markets Presentation

Mr. Hari Gopalakrishnan and Mr. Andrew Tirbeni, both with EQT Group, gave a presentation on EQT-BPEA Private Equity Fund IX.

Co-Investment Manager Search

Ms. Melissa Cahill, Mr. Joel Hwang and Mr. Ed Powers, all with HarbourVest Partners, gave a presentation on HarbourVest Custom Co-Investment Solution.

Private Markets Contract Discussion & Recommendation

Ms. Sanders, Mr. Barnes and Mr. Beers discussed EQT-BPEA Private Equity Fund IX and HarbourVest Custom Co-Investment Strategy with the Board. Ms. McManus moved, seconded by Ms. Jarrell, to commit \$100 million to EQT-BPEA Private Equity Fund IX. With no further discussion, and no objections, the motion carried. Ms. McManus moved, seconded by Ms. Hodges, to commit to a HarbourVest Custom Co-Investment Fund up to \$125 million. With no further discussion, and no objections, the motion carried.

Global Multi-Sector Credit Search

Mr. Fournerat and Mr. Barnes discussed Global Multi-Sector Credit search and finalists. Ms. Hodges moved, seconded by Ms. Mathews, to approve Bayview Asset Management, Irradiant Partners and Orchard Global as Multi-Sector Credit finalists. Mr. Beale reviewed the Total Plan performance. He stated that the preliminary monthly return for November 2024, was 2.5%.
